If located outside of Georgia: Southern Association of Colleges and Schools, New England Association of Schools and Colleges, Middle States Association of Colleges and Schools, North Central Association of Colleges and Schools, Northwest Association of Accredited Schools, Western Association of Schools and Colleges, the Alabama Independent School Association or the Southern Association of Independent Schools.
